Safe Environment Adult Learning Program

The Catholic Mutual **Safe Environment Program** is comprised of many components to increase awareness for protecting children and help adults recognize and report signs of abuse or neglect. This program includes:

- A 60-minute USCCB compliant training video: *Safe Haven—It's Up to You*
- *Safe Haven: Religious Education* is an 8 minute video that reviews your responsibility to observe and report abuse and neglect in different situations.
- Safe Environment Risk Alerts that can be used for continued training
- Ability to house your Code of Conduct, Mandatory Reporting Policy, and any other documents you would like users to read and acknowledge
- Flexibility to house diocesan-specific videos, Bishop messages, and other valuable information
- Database with unlimited storage to track all training and policy acknowledgment, allowing customized reports to be run for audits

Appropriate Relationships

Bullying Prevention Program

The **Bullying Prevention Program** was developed with children and adults in mind, and focuses on recognizing when bullying is happening, dealing with bullies, and best practices for preventing bullying. This program includes:
